Budget

Another required component of the grant application is the budget, including a narrative that connects the requested funding with specific elements of the proposal. On the application in Fluxx, enter an indirect expense rate (up to 15%) for your proposal budget, and then select the Proposal Budget Form link to open the table. Please note that the indirect expense rate will automatically calculate based on the rest of your budget. In the Proposal Budget Form, list personnel, other direct costs, and purchased services, and describe how the funds requested for each line item will be spent and how the amount was determined. Note that the Total Program Expense, Indirect Expense, and Expense Total will be calculated when you select the Save button.

For the personnel section, enter a brief personnel description, annual base salary, FTE, fringe percentage, CareQuest Institute grant support amount, and budget narrative for each line item. Also, include match support and other/in-kind support where appropriate. For the other direct costs section, enter a brief description per line item for direct non-personnel project-related costs, CareQuest Institute grant support amount, budget narrative, as well as match support and other/in-kind support where appropriate. Frequently Asked Questions

1. How can organizations apply for funding?

Organizations can apply for funding through CareQuest Institute's <u>online grants</u> <u>management portal, Fluxx.</u>

2. Where can organizations learn more about the grant process?

Organizations can find more information about the funding areas by visiting our grantmaking landing page or by getting in touch with a member of the CareQuest Institute grants team.

- **3. What types of organizations are eligible for funding?** CareQuest Institute makes grants to nonprofit or not-for-profit organizations in the United States and US territories. The Institute does not give grants to for-profit organizations or individuals.
- **4.** Should an organization submit a full budget as a part of the concept submission? If possible, however, organizations do not need a full budget when submitting a concept, which is the first step in the proposal process. Our hope is that after any concept is approved, the process for writing and submitting a full proposal is collaborative and iterative in a way that can clarify any budget questions.
- 5. Is there a funding amount maximum and/or a range for funding? We remain flexible in relation to minimums and maximums and consider the scope of your work as well as its alignment with our priorities.
- 6. How long is the typical grant period? Each grant award is made for at most one year, but grantees are welcome to submit new concepts and proposals following the end of their grant period.
- 7. Does CareQuest Institute have a specific geographic focus or area of interest? CareQuest Institute works to advance oral health system change efforts in a variety of geographic contexts; therefore, we encourage interested nonprofits to submit a concept regardless of their location or geographic focus. We expect that the work will have a local or state-based strategy, but we are also interested in thinking about how to apply learnings and findings from this work to national-level policy change, and we will welcome our grantee partners to engage in that conversation.
- 8. Which organizations need to submit a concept in 2024? We ask all interested organizations to submit a concept prior to submitting a full proposal.
- **9.** What budget line items are eligible/not eligible for funding? CareQuest Institute does not make grants directly to individuals and does not support capital expenses, direct service, mobile vans, or payments for procedures.
- **10.** Can organizations have conversations with the grants team before applying? Absolutely! We encourage all organizations to reach out to a member of the grants team to discuss the program or project for which you are seeking funding.
